Requirements to abstracts:

Accepted abstracts up to 2 pages A-4. Abstracts should be submitted according to the requirements:

1. Margins: top, bottom - 2 cm; left - 2.5 cm; right - 1.5 cm; line spacing - 1,0; font - Verdana; size - 10; style - normal; indentation - 1.25. Graphs and drawings are performed by built-in Word tools. References in the text should be presented in square brackets, e.g. [3, p. 15], where the first number indicates the serial number of the source in the reference list and the second one - the relevant page in this source. Formulas are performed using built-in editor and MS Equation formulas and are numbered to the right.

2. In the upper left corner to indicate Jel Classification System. In the upper right corner specify first name, surname of the author, below is the scientific degree, academic status, position, below - the organization of the participant. The titles should be typed in capital letters symmetrically to the text. The main text (after missing two lines).
